

Texas MOS&B Loses One of Its Finest

Bobby Gene Davidson, age 83, crossed over the river on Sunday, June 7, 2015 in Tyler, Texas and now rests under the shade of the trees.

Bobby was born February 5, 1932 in Argyle, Texas to Joseph Elmer and Myrtie Mae Brockett Davidson. At age 14, he joined the U. S. Coast Guard; at 17 the U. S. Air Force and at 18, became a U. S. Marine. Bobby was a Korean War veteran. Bobby attended North Texas State University and worked for the Atomic Energy Commission Idaho Testing Laboratory. He was engaged in construction and architecture in Dallas, Idaho, Alaska and Hawaii.

In 1998, he and Lois moved to Tyler where they became active in the heritage community. Bobby was a charter member and first commander of the Colonel Richard B. Hubbard Chapter 261 in Tyler. In 2001, he became Chief of Staff for Texas Society Commander Ron Aldis and served every commander thereafter. Bobby edited the *Clarion Call* for ten years, winning three national awards for best state society newsletter. He was awarded Distinguished Commander

Status and made Honorary Commander General for his service to the Order. Bobby was the originator of the annual Camp Ford Living History event. He served on the Board of Directors of the Smith County Historical Society, Camp Ford Historical Association and the Oakwood Cemetery Committee.




In the near future, I will forward you a full report of the 2015 National convention and the recent SEC meeting.

Request From the Texas Society Genealogist

I am requesting that three things be done when applying for membership in the Order:



- 1. All applications must have proper paper documentation for each generation. This may be birth, death, marriage records or wills, etc. They must be legal documents or copies thereof. There must also be proof of the ancestor's service. The application should be signed by the recommending member and the person approving the application at chapter level. These spaces are on the next to the last page of the application.
- 2. A check for National dues and state dues (\$10.00) should accompany the application. Please be sure to enclose the check for state dues to prevent delays.
- 3. The completed application should be mailed to me, Jim Templin, 2500 Woodlawn Drive, Ennis, TX 75119.

After I approve the application, it is sent to Headquarters. It is then electronically forwarded to the Genealogist General for his approval. Please be patient. This may take some time. Completing your application as indicated will speed up the process.




From the Texas Adjutant

This is the first time that I have been asked to address the Texas Society as your Adjutant. My words will be brief and to the point.

It is the responsibility of the Chapter Adjutant to collect and accumulate all dues for his chapter. This includes the Chapter Dues (set by Chapter), the State Society Dues (\$10.00) and the National Dues (\$35.00). These dues must be listed and shown by member with their member number. Deposit the money in your Chapter's bank account.

With one check and the list, forward accumulated State Dues to me at 722 Nandina Way, Waxahachie, TX 75165. Write another check and with the list, send the accumulated National Dues to the MOS&B Adjutant at MOS&B IHQ, P.O. Box 18901, Raleigh, NC 27619-8901.

Dues are to be received and registered by not later than the 31st of December for the following year or they are considered delinquent. Therefore, it is suggested that you begin collecting the dues about October. Please do not have your members send their dues in as individuals as this creates undue and excessive work and does not allow you to know for sure which of your members are active.



2015 Texas Society Convention

The 2015 Convention of the Texas Society of the Military Order of the Stars and Bars was held April 24 – 25 at the Homewood Suites in southwest Fort Worth. Twenty-two compatriots and sixteen guests attended from around the state. The Col. W. H. Parsons Chapter 273 served as the host chapter.

Scott Bowden



In convention on July 10, 2015 Alexandria, Virginia



Resolved that:
