### LAFAYETTE NATIONAL CONVENTION

I drove to Lafayette, Louisiana the first weekend in August to attend the National SCV/MOS&B Convention held at the Hilton Hotel and next door at the Acadiana Hotel. I really enjoyed the convention—outstanding speakers—and the opportunity to make new friends and see old friends.

The ability to browse through the "vendors area" for a couple of days is worth the trip to me. My only "disappointment" was the two resolutions put forward at our MOS&B convention - one to remove all requirements for SCV membership in order to join or belong to the MOS&B - and a second to maintain the requirement of SCV membership to join the MOS&B but no requirement to maintain SCV membership in order to maintain your MOS&B membership.

The first vote - on Resolution #1 to remove all requirements for SCV membership in order to join or belong to the MOS&B - was defeated by a vote of 87 to 80. Of course it required a 2/3 vote and was therefore far short of passage, but it was disturbing to me that almost half present would vote for this. I was further most unhappy when it was evident that our sister Army of the Trans Mississippi states, like Oklahoma, Arkansas and Missouri were really pushing this. Our ATM Dept. Commander, Curtis Hopper of Missouri, spoke in favor as well as Oklahoma and Arkansas representatives. I want you to know that I had two votes as our Texas Society Commander, and I voted NO. Likewise, I believe that all votes from Texas were cast against this resolution.


As much as I am honored to belong to the MOS&B and can therefore honor my ancestor who was an officer (just a 2nd Lt. - had been a Sgt.). I think that we all need to remember that we are SCV members first. I know that I feel that way. In the future I think we need to know more about certain candidates running for ATM Dept. offices as well as National offices in the MOS&B. The National Commander stood and said he was for this resolution to disassociate the MOS&B from the SCV. Texas Chapters cast a lot of votes. I intend to be more careful who I support because I have voted for some in the past that I will not support in the future. These are just my personal thoughts regarding what I think was the most significant votes cast at our recent National Convention. The old saying -"United We Stand, Divided We Fall" comes to mind. Regardless of the reasons, such a division would be seen as just that - we would be divided. Don't you know that would make our "enemies" happy. Such a division must not happen.

# CLARION CALL NAME—WHY?

The Texas Society of the MOS&B has had a publication for some time entitled "The Gazette" that has been prepared by the Society Commander . I intend to continue this, but to be very honest, I did not like the name "Gazette." It always left the wrong connotation in my mind. Walter Nass, our previous Society Commander, always told me I had a dirty mind when I mentioned this to him. However, it seems to me when I see "Gazette" on an old newspaper, it was some sort of less than desirable publication. Therefore, I have changed the name of our Texas Society publication to the "Clarion Call." The name was suggested by two in our Society that I admire and respect. My dictionary says CLARION is a call to action. The word CALL means to announce loudly or authoritatively - to command to come or a request to be present - a request to assemble, etc. I hope that everyone likes the new name. I think it is more appropriate for our publication.

Some question why we need to have such a publication? The Sons of Confederate Veterans, and our affiliated organization The Military Order of the Stars and Bars, are involved in important work these days. As the descendants of Confederate military officers and Officials of the Confederate government, I think we need to "stay in touch" with the hope that we can learn from each other, and therefore improve our local Chapters. stronger than our local MOS&B Chapters in Texas. I ask for the help of every member of the Texas Society in this endeavor. The new Chapter is located in DeLeon, Comanche County, Texas and plans to solicit members from the west central Texas region. The Chapter also plans to take advantage of today's technology and hold some of its meetings via the internet. This will allow recruitment of members from throughout the State. Regularly scheduled meetings will normally be held in conjunction with the 2nd Texas Frontier District Camp #1904 of the SCV, the Camp with which the Chapter is closely associated. The Chapter already has two new members completing their applications and one "at-Iarge" member is requesting transfer to our Chapter .

## A Suggestion to each MOS&B Chapter in the Texas Society

As the Texas Society Commander I realize that each Chapter is independent regarding their activities and programs. There are no requirements in the Society Constitution and By-Laws about how often each Chapter should meet or how their individual meetings should be conducted. I realize that some Chapters in this Society do not meet - at least not very often - and it is probably a fact that a few never meet. Other Chapters meet in conjunction with a SCV Camp. Some do meet independent of an SCV Camp and have their own regular meetings. It is not my intention to try and dictate to any Chapter. However, I do want to make some suggestions.

Military Order of the Stars and Bars membership would be enhanced significantly if the MOS&B Chapters did meet on their own. My thought is that a Chapter should consider Quarterly meetings - perhaps including the wives and children and other family members - perhaps at some Restaurant. A good brief program involving something of interest to our members, and a good meal, with each member ordering on his own and paying for his own bill. That way the person can have as much or as little as they desire. It is not that we are "elite" or "superior" to any other group - SCV - or whatever, but if we are to remain a part of the SCV/MOS&B organization, and be something other than just a group to carry an additional card, then we need to "find our spot" and work hard to be a success and improve our organization. Therefore, the following is another suggestion.

## A Request to each Commander of a MOS&B Chapter in Texas

I ask each Chapter to plan and host a special program to be held in early March of 2002, and hopefully each year thereafter. I selected March because it is before the beginning of summer when both State and National Conventions are held. Also, there are some important dates that this special program can be built around:

March 2, 1861, Texas was admitted to the Confederacy (Of course, March 2nd is also "Texas Independence Day" which ought to be a big holiday in our State, but unhappily it is not the big event it once was).

March 4, 1861, is the date when Miss Letitia Christian Tyler, grand-daughter of former U. S. President John Tyler, raised the First National Flag of the Confederate States of America.

March 11, 1861, the Confederate Congress adopted the Constitution of the Confederate States of America.

My thought is that each MOS&B Chapter would have a dinner meeting, with family and guests invited. The program, should be planned by each Chapter Commander, or by his appointed Program Chairman for this meeting. I am asking that a Rededication Ceremony be held where each MOS&B compatriot present will renew his vows taken at his Initiation at the time he joined the MOS&B. If for some reason your Chapter has not used this very brief Initiation Ceremony, this will be a yod opportunity for your members to take their special obligation.

Another part of this program can include an Honor Roll Ceremony for our ancestors. I realize that many SCV Camps have wonderful programs such as this, but our smaller group can allow for much solemnity and make it all more personal and add importance to the ceremony. Each member can "light a candle" (or candles) in honor of his ancestor(s). In addition to the ancestors of the members of the Chapter, special candles can be in the program for President Jefferson Davis, General Robert E. Lee, Generals Jeb Stuart, Albert Sidney Johnston, Nathan Bedford Forrest, etc. One to definitely be included is the namesake of your Chapter should it be named for an Officer. If possible, or practical, the use of a bugler to play taps can add to the program.

I will be happy to provide each Chapter in Texas a suggested program, including instructions, proper wording, etc., if requested. I sincerely ask each Chapter Commander to give this Request serious consideration. If you have any questions, or if any MOS&B member, not a Chapter Officer, has any questions, please feel free to contact me by mail or email or telephone. Even if some of our Chapters do not regularly meet as a separate and distinct organization, such independent meetings as mentioned above can give the Military Order of the Stars and Bars a renewed purpose and indicate our separate requirement, that of being a descendant of a Confederate Officer. Our organization being very small when compared to the SCV, can give our special programs the feeling of a "special family" - a group where we can support and honor our ancestors in a small solemn and sincere service.

In certain large metropolitan areas, it could be that more than one of our MOS&B Chapters can join together for such a program as that suggested. It might be easier, but there is nothing wrong with a small group meeting independently. Some of our MOS&B Chapters are small, and they can have as fine a program as a larger Chapter, or group of Chapters. Be sure to include family, including children, and friends. If you have SCV members with Officer ancestors who are not yet members of the MOS&B, perhaps such a meeting might be just what is needed to make them decide to join with us.

I have suggested that this program include both a Rededication Ceremony and a Honor Roll Ceremony for our ancestors. ## Some Interesting Dates

**Sept. 13, 1861** - Francis Key Howard, the grandson of Francis Scott Key, was arrested on order of U. S. General Banks, and taken to Fort McHenry charged with being an "active secessionist." This was 47 years to the day after his grandfather wrote the Star Spangled Banner, while a prisoner on a British War ship that was bombarding the same Fort McHenry.

Sept. 22, 1833 - Stephen Dill Lee was born. He would later be a General in the Confederate Army, and at New Orleans in 1906, he gave the Charge to the Sons of Confederate Veterans, as follows: "To you, Sons of Confederate Veterans, we submit the vindication of the Cause for which we fought; to your strength will be given the defense of the Confederate soldier's good name, the guardianship of his history, the emulation of his virtues, the perpetuation of those principles he loved and which made him glorious and which you also cherish. Remember, it is your duty to see that the true history of the South is presented to future generations."

Oct. 12, 1870 - General Robert E. Lee died.

November, 1861 - the first official battle flags were issued to General Beauregard's troops. This flag is properly referred to as the "Southern Cross."

### S.C. Boycott Fails

The year 1999-2000, the time the NAACP first enacted its boycott of South Carolina, state tourism revenues increased 11.1 percent. Even the New York Times called the boycott effort "a fizzle" and pointed out that the tourism dollars lost because of the boycott amounted to a "drop in the bucket" as far as South Carolina's \$7 billion tourist income is concerned. We all remember the big deal made on TV about how the NAACP boycott would ruin South Carolina. The daily mainstream press often tries to distort and manipulate or simply withhold information that would refute their relentless anti-southern propaganda. The politicians are so afraid to do anything that the Reverend Jackson or the NAACP might not like and therefore start a boycott. I think their bark is a lot worse than their bite. I have not seen the figures but I feel certain the same results will eventually come out regarding their boycott of Mississippi over the fact that the citizens of Mississippi voted to retain their current State Flag. At least I hope the results are the same.

### When did "The War" End?

I realize that, for some of us, The War is still not over. Most of us were taught that it ended on April 9, 1865 when General Robert E. Lee surrendered the Army of Northern Virginia at Appomattox Courthouse in Virginia. That was not really true because large Confederate armies were still fighting in the field. General Joseph E. Johnson surrendered his Army of Tennessee at Durham, North Carolina on April 26th. General Richard Taylor did not surrender his Department of Alabama, Mississippi and Eastern Louisiana troops until May 4th at Citronelle, Alabama, which is in Mobile County just north of the City of Mobile. What is generally considered the "last battle of the war" was at Palmetto Ranch

near Brownsville, Texas, and was a Confederate victory. It was fought on May 13, 1865. On June 2,

65, General E. Kirby Smith surrendered the trans-Mississippi Department at Galveston, Texas. U.S. President Andrew Johnson proclaimed the insurrection in Tennessee at an end on June 13th. Brig. General Stand Watie's troops surrendered in the Indian Territory on the 23rd of June. Gen. Watie was the last Confederate General to surrender his troops.

On November 4, 1865, the CSS Shenandoah surrendered in Liverpool to British authorities, after Captain James I. Waddell was informed on the high seas by a British ship that the Confederacy was no more. The Captain then put all guns below deck and sailed to England to surrender to the British Admiralty. When the British boarded the vessel, the last Sovereign Confederate flag was furled.

On April 2, 1866, President Andrew Johnson proclaimed the insurrection ended in all the former Confederate States except Texas. It was not until August 20, 1866, that Johnson proclaimed and declared the insurrection in Texas at an end. Texas had finally complied with the conditions of his Reconstruction proclamation. Some say that the "war against the south" continued for a hundred years, and some say that it has never ended and the southland continues to be punished to this day. The decision is up to you. As a Texan it sort of pleases me that Texas was the last State to officially reenter the Union. I think it was in 1870, but I cannot swear to that as I am writing this. Anyhow, it really was not all over when General Lee surrendered. That is a fact, regardless of what we were taught.

## Dues Reminder

We are all SCV members and this is just a reminder that your SCV dues to your Camp, Texas Division and National Headquarters become payable as of August 1st of each year. It is now SCV dues time and your SCV Camp should sending a statement soon or contacting you in whatever manner they use. These must be paid by May 1st to allow the Adjutants time to send in their required reports, etc. to the Nat'l. Hdqtrs. Be on the lookout for your dues statements. ## "Bonnie Blue Flag"

Bonnie Blue Flag, and Dixie were the most popular songs of the Confederacy. The words to Bonnie Blue Flag were written in 1861 by Harry McCarthy, an English-born vaudevillian. He set the words to an old Irish tune, The Irish Jaunting Car.

We are a band of brothers,
Native to the soil
Fighting for the property
We gained by honest toil.
And when our rights were threatened,
The cry rose near and far;
Hurrah for the Bonnie Blue Flag
That bears a single star!

chorus: Hurrah! Hurrah! For Southern rights, Hurrah! Hurrah for the Bonnie Blue Flag That bears a single star!

As long as the Union
Was faithful to her trust,
Like friends and brethren,
kind were we, and just;
But now, when Northern treachery
Attempts our rights to mar,
We hoist on high the Bonnie Blue flag
That bears a single star.
